Exorcism Gone Wrong; Two Children Dead by Christopher Lee Mojica

In a mountain community in western Mexico this past December, two young sisters were murdered when their family believed them to be possessed.

The brutal "exorcism" was carried out because relatives said that the girls' faces would take on animal features.

Judge Ana Maria Raya Razo said family members insisted faces of monkeys and demons would appear on the 7-month and 13-year old girls.

The incident was instigated after an aunt had recently gone to see a faith healer. The murders were committed by nine family members, including the girls' parents, grandparents and aunts.

Police reports indicate that during the ritual candles were lit, prayers were said and farm animals were sacrificed, as the 7-month old was severely mutilated and the 13-year old was tied to a stake and stoned to death.

An anonymous phone call led authorities, traveling on foot, to a desolate location in Guanajuato state township. Several other family members were discovered

locked up, also suspected of being possessed.

The family members admitted to the killings and said they had to kill the girls in order to save themselves from the demons.

Razo went on to say, "The psychiatric testimony showed that they were suffering from a delusional psychotic state, with paranoia and hallucinations."

The young girls' parents were found to have taken part in the killings, but were not convicted of murder, due to insanity. All nine were committed to a psychiatric ward for 40 years.

Available January 31, Tim Burton's *Corpse Bride* hits the shelves, just in time for Valentine's. It's a beautifully morbid love story with a dreadfully happy ending.

Tim Burton, the master of dark fantasy films such as *Beetlejuice*, *Edward Scissorhands*, *Nightmare Before Christmas* and *Sleepy Hollow*, graces the big screen once again with his second stop-motion animated feature film.

Based on an old Russian folk tale, the story is about a groom, Victor (voiced by Johnny Depp), who inad-



vertently proposes to a deceased bride (voiced by Helena Bonham Carter), who was murdered on her wedding day. The smitten Corpse Bride sweeps Victor away from his gloomy and boring 19th-century Victorian village to the vibrant, colorful and exciting world of the dead for the big wedding. Victor must find his way back to the land of the living before his "true" bride-to-be is given away to another.

Corpse Bride does not quite capture the creativity and magic of its predecessor and holiday classic, Night-mare Before Christmas. The sound track alone is a little bland and at times makes it feel like you're watching the Nutcracker. But with colorful characters, intricate miniature sets and impeccable cinematography, Corpse Bride is definitely worth your time.

Lady in White— a Tale of Ill-Fated Love

As Hammond was beginning to flourish, a young and beautiful Polish girl, named Sophia, caught the eyes of many. During this time it would have been customary to marry within one's nationality, but Sophia had found true love with a 23-year old of Puerto Rican descent. Theirs was a secret affair, as Sophia's parents would never have approved, and so they would meet along the isolated banks of the Calumet River near the outskirts of town. St. Valentine's Massacre by Christopher Lee Mojica

What's better than receiving a box of mystery chocolates and some overpriced flowers for Valentine's Day? How about some tickets to the Indiana Ghost Trackers' St. Valentine's Day Bus Tour!? (Now, that's sweet!). The tour is scheduled for many different stops around the Chicagoland area.

One of these stops will be the famous St. Valentine's Day Massacre site. The brutality of this event further cemented notorious gangster Al Capone's reputation as a brazen criminal, by devising probably the most creative and gutsy set-up ever to be plotted and executed.... literally!

Al Capone was one of the better known mobsters on the Chicago mob scene. The other was George "Bugs" Moran, who was in control of the North side and was cutting in on Capone's action. The saying "This town isn't big enough for the two of us" is pretty much the way it was back then. There was only room for one leader in the business of organized crime. Capone decided that the dance floor had one too many; he and Jack "Machine Gun" McGurn devised a plan to eliminate the competition. Knowing that he would be the number one suspect in the death of his rival,

Capone left for his summer home in Palm Island, Florida. With Capone far away from the Windy City, he had an airtight alibi. This left McGurn in command and in control of the job. To further complicate the investigation, McGurn assembled a squad of out-oftowners to make the hit harder to piece together. McGurn knew the heat would be on him as well, so he sealed his alibi by taking his girlfriend to a hotel at the time of the assassinations.

On February 14, 1929, at 10:30am, Moran and his men were to meet with a bootlegger in a parking garage at 2122 North Clark Street to purchase some hijacked liquor. Two of McGurn's men were staking out the garage and waiting for Moran and his men to show for the meeting. Once they arrived a call was made and the rest of McGurn's men, dressed in stolen police uniforms and driving a stolen police car, raced over to the garage. Acting as policemen, McGurn's men entered the garage and found Moran's men. Knowing the routine, Moran's men did not put up a fight and did what the "police" said. They were told to line up against the wall and, once relieved of their weapons, McGurn's men opened fire, killing all, but one, Frank Gusenberg.

As the icing on the cake, two of McGurn's men buttoned up their trench coats, raised their hands in the air and walked out of the garage being escorted by uniformed "policemen".

Thus, giving the appearance that a bust had just gone down.

When police finally arrived, they asked Gusenberg who shot him. His reply, "No one shot me."

What seemed like the perfect mob hit was actually a bit of a screw-up. Unfor-

tunately, Bugs Moran arrived late to the meeting and, noticing the police car sitting outside



the garage, he turned away. But, the massacre was a big enough sign for Moran to back off of Capone's territory. Moran himself said, "Only Capone kills like that."

No one was ever convicted for the St. Valentine's Day Massacre. Everyone had a pretty good idea of who was behind it, but with no evidence, no indictment.

Today, a small fenced park marks the location of where the garage once stood; a tree now grows where the bullet ridden wall was located. One rumor is that if you listen real close, you can hear the sound of guns firing or the yelling of men being gunned down.

Biograph Theatre

Last year's St. Valentine's Day Bus Tour was a great turn out and this year should be even better. One of the stops on the bus tour will be the Biograph Theatre, just across the street from the Red Lion Pub. This is the site where John Dillinger was shot dead in the alley.

Last year's tour produced several great pictures. One in particular was taken by IGT's very own, Sheila Reed. The picture was taken very near the front of the theatre on her way to the alley.

Notice the woman in the picture and the image that is captured from the shaky photograph. The image of a pale woman, in period clothing, appears to the left of the woman in the black coat and possibly a second face to the right of her, as well. If you compare the faces, you will notice there are similarities between the two.

Is this just a case of a photographic anomaly or something deeper?? You can decide for yourself.
